# **UPDATES**

#### **Dementia Friendly Faith Communities**

The Working Group has agreed the first draft of a 'guide' which is based on the ECO Friendly Churches model using bronze, silver and gold levels to mark achievement. The draft guide is currently out for consultation to a wide range of individuals and faith communities and the response has been very positive to date. The consultation includes questions about how the information could best be presented so that the next stage of development can encompass the ideas so that we make sure that it is a helpful and constructive aid to ensuring that older people and those experiencing dementia continue to be included in their faith community and that those who provide support and provide worship have a stronger understanding of the needs of people with dementia and those who care for them.

#### **Spiritual Care Education in Continuing Care Units in the NHS**

FiOP is currently undertaking a small research project in these units in collaboration with the NHS Lothian Chaplaincy. We want to find out –

- the extent to which spiritual care is understood
- what training is available and
- how spiritual care is delivered in these units which provide end of life care

We have been interviewing a range of staff in each setting and hope to complete the report in the early autumn. This builds on a previous study undertaken by Helen Welsh for FiOP in 2015 in relation to care home staff which concluded that more work was required to support their education in respect of spiritual care.

#### Faith in Older People and Scottish Partnership on Palliative Care Joint Conference

The aim of the conference, which was held on Tuesday 7 June 2016, was to consider the impact of recent policy initiatives in relation to spirituality and palliative care and the extent to which spiritual care is seen as an integral part of person-centred care towards the end of life.

The conference, which was attended by 60 people, provided an opportunity to consider the policies and their impact on practice in a variety of settings which reflected the integration of health and social care. Delegates had an opportunity to share experiences, to discuss opportunities for improvement and to identify how such improvements might best be supported.

There were excellent presentations on the Palliative Care and End of Life Strategy and the Spiritual Care Delivery plan from Tim Warren, Scottish Government and Sheila Mitchell, Head of Spiritual Care Unit in NHS Education for Scotland. The focus on improvement was presented by Elaine Maclean (Care Inspectorate) and Shaun Maher (Scottish Government) and Donald Macaskill (Scottish Care) provided an over-view of spirituality and palliative care in the context of the integration of health and social care. The presentations were followed by lively discussion in workshops and in the plenary.

The key issue was to see how the policies which reflect the other are implemented in practice and what the impact is on both health and social care staff.

The collaboration between FiOP and SPPC is one of longstanding and is constructive and valued. A conference report will be produced.

### REVIEW

**Nothing about us, without us! 20 years of dementia advocacy.** Christine Bryden (2016) London, Jessica Kingsley Publishers

Christine Bryden is an inspirational person with dementia who has devoted her life, since she was diagnosed, to talking openly about her experience. She has travelled the world speaking at conferences. She has also written two influential books: Dancing with dementia and Who will I be when I die?

Christine Bryden was diagnosed with dementia at the age of 46 which meant that she had to retire very early. The shock sent her into depression from which she recovered and she decided that her way of coping was to become an advocate for people with dementia. She says she has adapted to a slow but steady decline and this book takes us through her journey so far.

This third book is a collection of twenty years of her power-points with her commentary below. She is wonderfully articulate. You find yourself wanting to quote her all the time e.g:

"Challenging the lies surrounding dementia by living positively with dementia"

"It is the way you talk to us, not what you say, that matters"

Christine Bryden's faith is very important to her and she emphasises this more and more as she become more impaired. She says: "To cope with this confusing reality is a daily struggle. My keys for coping are a strong Christian faith, Paul my enabler, my Exelon and a positive attitude. Our faith, or our spirituality is crucial. We are losing our cognitive self – even a reliable and coherent emotional self. What remains is our spirituality. We need you to help us connect with to whatever has given us true meaning in life..."

It is hard to stop quoting her. Every page has remarkable insights which help us to understand better the experience of dementia. This book would be a great help to anyone or any group of people wanting to be more dementia friendly.
