Support from our Funders and other contributors is so much more valuable to us because the focus of our work is 'not everyone's cup of tea.' Nonetheless, with that 'Invictus spirit', 'blooded but unbowed', and a lot of 'onwards and upwards', we endeavour to push through to progress our current strategic themes. These incorporate, end of life matters; death, dying and bereavement; Anna Chaplaincy spiritual care for older people; dementia support resources, including FiOP's interactive learning resource, 'One step at a time'; and, the 'Gift of Age Report. Both are significant pieces of work and continue to be widely disseminated. One Step at a Time (faithinolderpeople.org.uk) The-gift-of-age.pdf (faithinolderpeople.org.uk) FiOP continues to reach new audiences through stimulating and thought-provoking online Seminar Events, where participants regularly zoom in from different time zones across the globe.

And, lest I forget. Cutting across all our strategic themes is that of chronic loneliness and isolation in older people. However, it just doesn't cut, it wounds.

It is our hope that a more compassionate and caring society would help them navigate the path and walk alongside.

## Introduction

Every year is different. We find new collaborators; find new potential to increase understanding of spiritual care and to participate in decision making and policy development. Most important of all we strive to make a difference for older people and those who care for them in relation to their spiritual wellbeing.

During the year we highlighted the importance of spiritual care in building resilience, underpinning good mental health and mitigating the effects of loneliness and isolation.

Our work around spiritual care will never be complete, but we brought several major pieces of work to fruition. The Gift of Age report setting out the contribution of older people within our faith communities came to an end with two conferences and the report being widely disseminated in partnership with Volunteer Scotland together with a joint policy statement with Volunteer Scotland.

FiOP's contribution to the Scottish Government's Spiritual Care Framework was completed when the Framework was published in May 2023. We were proud to be a member of the Advisory Group for this work and will be taking forward some of the work outlined in the delivery plan. This includes the development of a course which will encompass staff in many different roles and at different stages of their careers to have a stronger understanding of the benefits of spiritual care/wellbeing to the lives of those for whom they care but also in nurturing their own spiritual resilience in the face of the many challenging circumstances they will meet.

The evolution of FiOP's resource in support of people experiencing dementia within our faith communities continued with the publication in May 2023 of the on-line resource – **One Step at a time**. We were very grateful to all those who contributed to the development of this resource – people experiencing dementia, their carers, clergy and pastoral carers.

These were major projects in which FiOP was supported by an experienced and skilled group of associates. As a very small organisation our associates are vital in bringing in expertise and knowledge. FiOP also benefits hugely from our collaboration with a range of organisations both within these projects and in bringing their own specific perspectives through the range of seminars organised by FiOP throughout the year.

We know that we will be facing funding challenges given the reductions in funding from the Scottish Government so we appreciate the Scottish Government Grant to undertake an education resource project and will seek funding to support all our core work around education, awareness, and influence.

## The Power of the Possible / The Gift of Age

This was the title of the final conference in promoting this project although we will continue to disseminate the report and to highlight its contribution to the Scottish Government Volunteer Strategy. We are immensely grateful for the partnership with Volunteer Scotland with which we produced a joint policy statement. It is essential that we recognise the significant contribution of older people and faith communities to the wellbeing of our society.



Faith in Older People undertook a major and unique survey of the contribution of older people within and from our faith communities. The overall aim of the research was to identify and better understand the contribution made by older people in faith communities to volunteering, community well-being and citizenship, highlighting the voluntary 'ministry' which lies at the heart of Christian faith, and is also echoed in all other faiths. To achieve this, we had the following objectives:

- Understand the extent to which older people sustain faith communities through voluntary service
- Learn about the impact from the experience of the current 'lockdown' on older people undertaking voluntary service
- 'Map' the needs, contribution, and potential of older volunteers in faith communities
- Identify examples of innovative and challenging practice, particularly ones which have developed in response to the pandemic, exploring how sustainable they are in practice

The research was supported by the TOR Christian Foundation. It is important that the research findings are disseminated as widely as possible to enable individuals and different faith communities to learn about the outcomes and to hear about the range of initiatives across Scotland. 


Fig 1. Income




Fig 2. Expenditure



## **End of Life Matters**

The FiOP Director continues to be a member of the Scottish Government Advisory Group on Palliative Care and End of Life Matters and serves on its Education Sub-Group. It has been important to be a member as it recognises the contribution that FiOP makes and how it reflects the inclusion of spiritual care as a specific element.

- FiOP continues to facilitate an End-of-Life Skills for Everyone Course and held a course in the summer of 2023 in collaboration with Scottish Partnership on Palliative Care (SPPC)
- FiOP continues to raise awareness of the issues with faith communities through its newsletter
- Contributed to the SPPC Annual Conference and exhibited a poster. Also contributed an on-line poster at the NHS Education Bereavement Conference.

## **Anna Chaplaincy**





FiOP has had a strong focus on the importance of Anna Chaplaincy in support of older people within our care homes. It has been a delight to work with the Anna Chaplaincy which comes under the aegis of the Bible Reading Fellowship. We have held a number of awareness raising sessions both on line and in person during the year.

#### **Debbie Thrower**

FiOP has worked closely with Anna Chaplaincy over the past two years and have appreciated the enthusiasm, knowledge and inspiration of Debbie Thrower who founded Anna Chaplaincy. Debbie retired in September 2023, and we wish her well and give thanks for all her support.



#### **Debbie Ducille**

We continue to work with her successor Debbie Ducille with whom we held two workshops as part of the 'Big Story' day organised by St Mary's Scottish Episcopal Cathedral, Edinburgh.



A wonderful outcome of these workshops was the licensing of an Anna Chaplain from within the Scottish Episcopal Church to join the existing one from the Church of Scotland.

# Practical approaches for spiritual care among older people- the potential of Anna Chaplaincy

Professor Swinton focussed on the importance of knowing someone's story and how the Purple Bicycle project provided a way of eliciting what matters to an individual.

**Donald Macaskill spoke movingly about the value of our care homes and what they bring to older people as their needs change** "In other words, care homes are not places where the task is to **exist** but rather, and with compassionate support and skilled professionalism, they **can** become places where people grow until the end of their lives, changing and moulding their days to the new rhythm of their experience. They are places where individuals are enabled to 'tell their story' and as Maya Angelou has said: "There is no greater agony than bearing an untold story inside you."

## **Tackling Loneliness and Isolation in our Communities**

FAITH IN OLDER PEOPLE AND INTERFAITH SCOTLAND: A JOINT EVENT TACKLING LONELINESS AND ISOLATION IN OUR COMMUNITIES

FiOP held this online conference to highlight the issue of loneliness by discussing the Scottish Government Policy on Loneliness; the action that faith communities do and can take



to tackle loneliness and to explore proposals for the future. The Government Strategy has been updated. We know that faith communities play a significant role in supporting people who feel lonely and isolated, so it is important we take this opportunity to consider the issues and differing roles.

Our speakers included Maureen Sier, Interfaith Scotland; Paul Okroj, Chest Heart and Stroke Scotland; Susan Hunter, CEO of Befriending Scotland and Srihari Vallabhajousula – Hindu Community and then in conversation with representatives of faith communities.
